

**COMMUNITY IMPROVEMENT GRANT 2022-2023**  
**Dublin Economic Development Corporation**

The Dublin Economic Development Corporation (DEDC) has budgeted funds for Community Improvement Grants. These funds are available on a first-come, first-serve basis for those that meet the requirements until funds are depleted. DEDC will pay up to **\$2,500 on an 80-20 percent match.**

**The following steps must be taken in order to receive these funds:**

1. The applying entity must operate within the City of Dublin or its ETJ (extra-territorial jurisdiction of ½ mile outside city limits). An exception might be considered if the property provides significant financial impact or public service for the City of Dublin.
2. All funds must be used as specified in the application, unless otherwise approved by the DEDC Board.
3. The monies will be awarded to the grantee (before or after project completion) at the discretion of the DEDC Board.

Your application will be reviewed by the DEDC Executive Director and, if it meets the criteria set forth in this application, it will be placed on the agenda for an EDC meeting at which time it will be discussed and acted upon.
